DCNR Announces Funding for Greenway Projects Funded Along Every Branch

The Department of Conservation and Natural Resources announced 198 grants totalling \$26.5million for recreation and conservation projects across the state.

We are pleased to share that the Susquehanna Greenway corridor will see the impact from this investment through many funded project partners. SGP received \$165,000 from the Environmental



champion for the Susquehanna River Watershed, Pennsylvania's most important natural resource and the largest tributary to the Chesapeake Bay. We work to advance for public and private efforts to connect people with our natural and cultural resources, and promote a sustainable and healthy environment.

Other partners working along the Greenway include the Endless Mountains Heritage Region, the Lancaster County Conservancy, the Pennsylvania Environmental Council, the PA Organization for Watersheds and Rivers, and the Susquehanna Heritage Corporation. Many Greenway counties also received funding for recreational, trail, or park projects that will help to build the Susquehanna Greenway. PA Water Trails - Economic Drivers



Visitors to four Pennsylvania water trails during the summer of 2012 generated almost three-quarters of a million dollars in economic activity and supported 11 full-time jobs.

The survey, conducted by ICF International on behalf of the Pennsylvania Legislative Budget and Finance Committee, gathered data from 352 interviews of water trail visitors from July to September on four of the state's 21 water trails: the Schuylkill, Susquehanna – North Branch, Juniata, and Three Rivers. 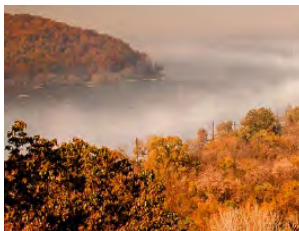
Public Access for West Branch

A bid totaling \$343,850 was awarded last month by DCNR to a HRI Inc., a State College construction company for construction of a new public river access launch for kayak and canoes on the West Branch of the Susquehanna River. HRI Inc. will be overseeing construction in the Sproul State Forest District, Grugan Township, Clinton County.

The launch will increase public access and public safety. It will be located along the 20 mile stretch of river between Hyner View State Park and Lock Haven. A spring 2013 construction start is anticipated.



Conservation Summit Rescheduled



Hurricane Sandy forced the postponement of the Conservation Landscape Summit, originally planned for Oct. 29-30. The summit has been rescheduled for Jan. 14-15, 2013 in Harrisburg. The goal of the summit is to build understanding of and enthusiasm for packaging conservation, recreation

We often hear how big cities like Boston, Chicago, San Francisco, and Portland, Oregon—have taken measures to enhance their livability through walking and biking improvements that improve connectivity. “But,” Jeff Speck laments in his new book, *Walkable City*, “these locations are the exceptions. In the small and mid-sized cities where most Americans spend their lives, the daily decisions of local officials are still, more often than not,

making their lives worse.” Speck describes how making walkability happen is relatively easy and cheap; seeing exactly what needs to be done is the trick. In this new book, Speck shows how simple decisions have cascading effects, and how we can all make the right choices for our communities. program, the Central Pennsylvania Rowing Association (CPRA). Many more have shared a meal at his riverside restaurants - Tedd's Landing, Tedd's On the Hill, and Skeeter's BBQ.

"The land from which we row actually belonged to John," said a statement from the CPRA Board. "He allowed the club and the schools to use that land because he wanted to share his love of the river and rowing with as many people as possible. He started teaching his wait-staff to row in the late 1990s and that group of adult rowers eventually became the club that we enjoy today. In many ways he really is the Father of Rowing on Lake Augusta. He will be missed."

American Shad in the Susquehanna River Basin by Richard Gerstell

It's hard to imagine a time when the Susquehanna River was choked with fish during the perilous spring migration of the mature American shad, the largest herring in North America. This native fish used to travel from the salty ocean to the Chesapeake Bay estuary and into the freshwater of the Susquehanna River to spawn in huge numbers and supported one of the largest fisheries along the coast.
