

### Rock Run Watershed Assessment Proposal Topic of TU Meeting

Shawn Rummell, Field and Research Coordinator of Trout Unlimited's Eastern Abandoned Mine Project will be the featured speaker on **Wednesday Nov. 12 at 7:30 p.m.** at the monthly meeting of Susquehanna Chapter TU in the Fellowship Hall of First Presbyterian Church, E. 3rd and Mulberry Sts., Williamsport. Rock Run, tributary of Lycoming Creek at Ralston, is well known as one of the most scenic mountain streams in PA as well as a favorite and historic trout stream. However, legacy coal mining, acid rain deposition, acidic headwaters bogs, and geology lacking in acid buffering capacity have compromised the watershed's ability to be a productive trout fishery.

Dr. Rummell will present information describing how TU's Eastern Abandoned Mine Project can facilitate the process of obtaining a grant to perform a technical assessment of the Rock Run watershed to determine water quality issues and opportunities to remediate and improve the watershed's aquatic and fishery resources.

All members are encouraged to attend to hear how our chapter can assist and participate in laying the groundwork for potential projects to improve this incredibly important and beautiful natural area.

### Muncy Creek Watershed Association Public Meeting

Our association accomplished a significant stream remediation project on Little Muncy Creek at Lairdsville. Corey Richmond managed lots of coordination, and volunteers installed 9 multi-log vanes in the creek bank September 25 with the aid of Brian Smith Excavating. Local watershed members did most of the hard manual work, and we were fortunate to have 4 capable Lycoming College students contribute their help during the afternoon. Grass seeding and mulching was done the following day by Corey Richmond & Carey Entz-Rine. We will appreciate several volunteers to help plant potted trees and shrubs in the disturbed areas of the creek bank.

Our meeting place will be 547 Woolen Mill Rd, Hughesville. The Hughesville Municipal Treatment facility has a very nice conference room we are permitted to use that evening. Directions: at the Wolf Township building on East side of Route 405, (not far from McDonalds) turn East onto Boak Ave; turn right at T onto Woolen Mill Rd; continue approximately 1/4 mile to the facility.

### New River Access Coming Soon! Construction Starts in Jersey Shore

After over four years of planning and fundraising, the Borough of Jersey Shore awarded the public river access project to Mid-State Paving and they expect to begin Phase I of the construction the beginning of October 2014.
