SGP Board Announces New Executive Director

Corey Ellison to Step into Position as of December 1st

The Board of Directors of the Susquehanna Greenway Partnership (SGP) is pleased to announce that Corey Ellison has been named the new Executive Director, effective December 1, 2018. Ellison succeeds Tali MacArthur. As the new executive director, Ellison will oversee the staff and work with the Board of Directors to develop a new strategic plan to guide SGP in its second decade of work. She will liaison with local, county, state, and federal officials and agencies, as well as other partner organizations on developing a 500-mile greenway of land and water trails throughout Pennsylvania and will be setting program and project development goals and priorities to make this vision a reality.

Life Jackets Required on River

Mandatory November 1st - April 30th



Don't forget! Wearing a life jacket is now mandatory on the river from November through April. The regulation states: "a person shall wear a Coast Guard approved personal flotation device (PFD or life jacket) during the cold weather months from November 1st through April 30th while underway or at anchor on boats less than 16 feet in length or any canoe or kayak." Jersey Shore Bike-Ped Audit Completed

Working Towards Trail Development in this River Town

The Jersey Shore Borough recently completed a Community Bike and Pedestrian Audit that was intended to raise awareness about the importance of bicycle and pedestrian-friendly community design for encouraging active and healthy lifestyles, as well as help organize the community around bike/ped issues, identify impediments to safe walking and biking, and identify priority projects for implementation. Funded by a Peer Grant from the Pennsylvania Department of Conservation and Natural Resources (PA DCNR), the Susquehanna Greenway Partnership (SGP) and a professional consultant facilitated the project, in collaboration with PennDOT Bicycle and Pedestrian Coordinators, representatives from your Metropolitan Planning Organization and County Planning Department, and a diverse local Study Committee.



Other Susquehanna Greenway River Towns are encouraged to pursue similar audits to empower community leaders and residents to get the funding needed to implement priority bicycle and pedestrian improvement projects. Community Designated Official Susquehanna Greenway River Town

Bloomsburg, PA - On Monday, October 22, the town of Bloomsburg saw a multi-year effort come to fruition when it received its official designation as a Susquehanna Greenway River Town at a ceremony held during the town council's meeting. Executive Director of the Susquehanna Greenway Partnership (SGP), Tali MacArthur, presented Mayor William Kreisher and Town Administrator Lauren Martz with the achievement. "SGP is so happy to welcome Bloomsburg into the River Town Program," lauds MacArthur. "This designation recognizes Bloomsburg's long history with the Susquehanna River, and complements its efforts to continue to grow and celebrate its connections to the river, as well as take advantage of the many economic development opportunities that the river fosters."

The public is invited to vote online for the 2019 Pennsylvania River of the Year until January 4, 2019. The four waterways nominated for 2019 are the Clarion River, Conodoguinet Creek, Delaware River, and Lackawanna River. After a waterway is chosen for the annual honor, local groups implement a year-round slate of activities and events to celebrate the river, including a paddling trip, or sojourn. The organization nominating the winning river will receive a \$10,000 leadership grant from DCNR to help fund these River of the Year activities.
